Wertheim has had a municipal family pass since 1987. It offers numerous benefits, especially to families with low incomes and several children.

From 2022 onwards, the benefits of the family pass will be improved, and the group of eligible persons will be expanded. These new, family-friendly regulations should enable even more families to enjoy the benefits offered by the family pass.

For example, family pass holders may receive a reduction up to 50 percent on admission prices and user fees at a large number of facilities, such as the youth music school, the municipal open-air swimming pool, the swimming pool, and seminars at the adult education center. I would particularly like to point out that the wide range of these discounts also includes all municipal and church kindergartens and the reliable elementary school.

We are pleased if you make use of the offer of the family pass of the city of Wertheim. This flyer informs you in more detail about the benefits, eligibility and application procedure.

Family Pass



What does the Family Pass offer?

Those who have the Family Pass receive up to a 50 percent discount on admission prices and user fees at the following facilities:

- All church and municipal kindergartens (also additional fees for extended care services)
- Leisure activities of municipal youth work during school holidays
- Reliable elementary school (but no double funding for sibling reduction)
- Lunch catering in Wertheim schools and kindergartens
- Christwiesen outdoor pool and indoor pool at Dietrich Bonhoeffer Gymnasium (time tickets)
- Courses, lectures and seminars at Wertheim Adult Education Center
- Municipal music school (however, no double funding in case of sibling discount)
- Offers of the city library
- County Museum and Glass Museum (reduced admission prices)
- Events of the Badische Landesbühne, the Kulturkreis, the parishes and the city of Wertheim (reduced admission prices)

Pupils who are not in receipt of BAföG or vocational training allowance receive a refund of 20 percent of the school transport costs which they have to bear according to the statutes of the Main-Tauber district (in the case of annual passes, on a pro rata basis for school months).

Who can apply for the Family Pass?

- Families, including single parents, with at least one child*, living in the household, whose income does not exceed the following income limits**
- Families, in whose household a severely disabled child lives (GdB 50 percent)*** [Degree of Disability]
- Beneficiaries according to SGB II/XII, the German Housing Subsidy Act or child allowance***

* all children of the household who are entitled to child benefits, i.e. minors and adult children in

** Entitlements under the Good Childcare Act and the education and participation package must be applied for with priority!

*** each Stage/Funding rate 1

How to apply for the Family Pass?

The Family Pass is applied for at the Wertheim City Administration in the Citizen-Service-Center of the City Hall, Mühlenstraße 26 (opening hours Monday to Thursday from 8 am to 6 pm, and Fridays from 8 am to noon). To make an appointment, please call: (09342) 301-271, -272 or -273.

The application can also be made by E-Mail (familienpass@wertheim.de) or via online form at our website (www.wertheim.de/familienpass)

When you apply for the family pass, please submit the required documents. These can be the last 3 pay slips, notices about the receipt of social benefits or the severely disabled certificate.

The family pass is valid for the duration of the current calendar year and can be applied for and issued again in the following year, provided that the requirements are met. The benefits are only granted from the time of application, so it makes sense to apply for the family pass in January.
