

# Resort TAX

## for the administrative district of Wertheim



### Why Resort tax?

Health Resorts and other areas of tourism can raise a resort tax, to cover the costs for establishing and maintaining recreational facilities.

### Who is obligated to pay resort tax?

All visitors in the city are obliged to pay. Residents of Wertheim are not obliged.

### How high is the resort tax?

The resort tax is 1.00 € per person, per night.

### Who is exempt from resort tax?

1. Non-residents that are only staying in the city for a day. (daily tourism)
2. Children under 17 years.
3. **Families** of residents who are visiting, free of charge and not taking part in any recreational activities and/or resort facilities.
4. Participants in congresses, training courses and conferences in the community, if the participation is predominately job related.
5. Non-residents, which are working in the city. (on site-, assembler etc.), § 43 exp. 2 KAG.
6. Residents of partner cities and participants of student exchanges.
7. Residents of the community, who mainly live elsewhere, but have their second residence in Wertheim.
8. **Disabled and severely handicapped** persons, as long as they are not capable of taking part in any recreational activities and/or resort facilities. The handicap level must be at least 80% and this must be documented by a doctor through a handicapped ID.
9. **Chaperons** of disabled and severely handicapped, if the chaperon does not participate in any recreational activities and/or resort facilities.

### Who is entitled to a guest card?

All individuals paying resort tax are entitled to a guest card.

### Which offers are included with the guest card?

Visitors profit from the guest card through reduced or free of charge entries to the following facilities:

- Graftschafsmuseum: 1.00 € discount on entry fee
- sightseeing tour of the city/castle: 0.50 € discount p. person p. Tour
- nightwatchman tours:
- museum "Schlösschen im Hofgarten": 1.50 € discount on entry fee
- Glass museum: 0.50 € discount on entry fee
- Tourist information: 3.00 € discount on E-Bikes rental (per day)
- Indoor and outdoor pool: Wertheim 0.50 € discount on entry fee
- Reederei Henneberger, boat trips on the main 1.50 € discount p. boat trip
- Wonnemar Marktheidenfeld: 10 % discount on the regular entry fee
- visit monastery Bronnbach: 1.00 € discount on entry fee
- Toppels Haus (upside-down house): 0.50 € discount on entry fee
- Climbing centre Wertheim: free non-alcoholic beverage with ticket
- Minigolf Wertheim: 0.50 € discount on usage fee for an adult
- Art of Chocolate Wertheim: 10 % discount from a purchase of 10 €
